If accepted to The Harbor Home, you are required to pay the weekly rent of \$150.00. Failure to meet this financial obligation will result in discharge and possible violation of parole conditions.

I certify that the information in this application is true and correct to the best of my knowledge and belief. I understand that if I am accepted as a resident, a search of my property and possessions will be required. I also understand that use and/or possession of drugs and alcohol, disruptive behavior, and non-payment of rent and fees will cause my immediate eviction from the facility without recourse.
